Digital Financial Inclusion

The 'Financial Inclusion Global Initiative' (FIGI) is a 3 year programme of collective action to advance research in digital finance and accelerate digital financial inclusion in developing countries. Led by ITU, the World Bank and CPMI - with support from the Bill & Melinda Gates Foundation - FIGI will provide technical assistance to China, Egypt and Mexico in their efforts to create policy environments able to stimulate financial inclusion. Other focus areas are the relationship between reliable ID systems and financial inclusion; digital payment acceptance by merchants and their customers; and security and trust in digital financial services. The Posts in Asia can play a central role in Digital Financial inclusion as a Cash in cash out point for financial institutions and as a credit rating agency for FinTechs in Rural Areas.
