Opening the Forum was Deputy Director-General of UPU IB, Mr Pascal Clivaz, the keynote speaker for the theme, "One Ocean -Many Currents: Facilitating Sustainable Global Trade".

Forum's first panel gathered industry insights from CEOs in different regions. They remarked that the pandemic had further accelerated the decline of the traditional letters business, forcing them to prioritize digitization and diversification, and managing services with fewer resources.

UPU to discuss Wider Postal Sector Players at 2023 Extraordinary Congress



Extraordinary Congress for a decision.

The 27th Universal Postal Congress in Abidjan, Côte d'Ivoire, unanimously approved the hosting of an Extraordinary Congress to decide on plans for opening up the UPU to wider postal sector players (WPSPs).

Hosting an Extraordinary Congress was one of a series of proposals put forward by a special UPU task force created in 2019 to study the possibility of engaging wider postal sector players in the UPU's activities.

As part of the approved proposal, the UPU's Council of Administration (CA) will be responsible for presenting a concrete, step-by-step opening plan considering future structural changes, wider postal sector participation methodology, and a corresponding financial contribution model. That plan will be presented to the 2023

More immediately, the UPU will reform its Consultative Committee, a UPU body that allows wider sector players to contribute to UPU dialogue, but without participating in decision-making processes, to allow more flexibility to those wider postal sectors wishing to participate. This includes the introduction of additional membership groups.
