- Global requirement to IMPROVE overall SECURITY
- While maintaining HIGH QUALITY of service
- EAD facilitates exchange of customs and security information
- Among DESIGNATED OPERATORS, CUSTOMS AGENCIES & CARRIERS
- Expediting CUSTOMS PROCESSING of MAIL ITEMS
- Supporting AVIATION SECURITY
- Data reuse for process AUTOMATION, DELIVERY planning and CUSTOMER service

The Legislative Landscape is Changing Fast...



USA

- US national legislation requiring e-data already in place.
- STOP Act
- 70% of incoming items by 31 December 2018
- 100% by 1 January 2021
- Mandatory for EMS

ΕU

- UCC legislation mandates electronic pre-advice for all import traffic
- · VAT de minimis removal
 - 1 January 2021
- Risk Assessment ICS-2:
 - 30 March 2021

Russia August 2018

- Federal Act (№ 289фз),
- Law requires electronic data or customs
- Lack of electronic preadvice already leads to a long transit and delivery times

China November 2018

- Legislation for e-data enforced
- GACC Announcement No. 164

Pre-loading requirements focus on ITMATT + PREDES UPU Regulations 08-002 §4bis 1 March 2020 (PREDES for all items containing goods)

Brazil

- Lack of electronic preadvice can lead to a long transit times
- New laws demanding more data being developed

Australia

- De minimis threshold removal.
- NNF 2016/170
- 1 July 2017

Key EAD milestones



31.12.2018 USA STOP Act

70% of all incoming items containing goods by 31 December 2018 100% by 1 January 2021 Mandatory for EMS 1.3.2020 S9/S10 linking S9/S10 linking (all items in PREDES) will be required for all items (including non-tracked letter post items containing goods)

1.1.2021 EU VAT change

Abolition of the current VAT exemption for goods in small consignment of a value of up to EUR 22 to European Union


1.1.2021 Mandatory ITMATT

Mandatory ITMATT for all items containing goods

EU PLACI ICS-2 R1 (predeparture)

Pre-loading item - receptacle level info needed for ICS2 (flows 1-7 of EAD modelpre-departure data sent by the origin Post, and elayed to ICS-2 by the European Post at destination. ICS-2 R2 (pre-arrival)


Pre-arrival consignment level, IATA air cargo manifest into needed for ICS2 (flow 8 of EAD model - prearrival data sent by airlings).



Recent efforts in capturing EAD data



- Work closely with MNC customers to transmit data directly to SingPost
 - Via API / Flat files
- For SME customers, we have an online platform for customers to create orders and print labels.
 - Via Ezy2ship
- For Retail customers, we are working on a suite of changes to allow data collection and posting.
 - Upgrading Online Platform (ezy2ship) to mobile enabled
 - Upgrading our existing self-service automated machine kiosks (SAM Machines) at Post Offices to enable customers to create orders, print labels and make payment.
 - Possible deployment of tablets at Post Offices to enable customers to create orders, print labels and make payment.
 - Work in progress and expected to be ready before June 2020
 - Currently, for retail posting bound for US, we are capturing the data manually backend.




EAD in SingPost

Challenges & Efforts to increase data quality



- Changing the behaviour of how Public post their packages
 - Now, Public just need to write address on package, buy stamp and send
 - Marketing & Awareness
 - Roll out incentive to get more customers to use Ezy2ship and print label before arriving at the post offices to post
- Need to provide nested PREDES for "U" series barcodes for untracked packets
- Close monitoring of data sent by Corporate customers and continuous effort required
- ITMATT data is created and transmitted to Postal Administrations
- EMA
- Every 2 hours

Dear Sir/Madam.

The designated operator of SINGAPORE, Singpost, asks us to inform the designated operators of other UPU member countries to include, whenever possible, the addressee's telephone number for all registered items, small packets containing goods, parcels and EMS items sent to Singapore.

The addressee's telephone number should be provided (if possible) as part of the data elements to be transmitted via EMSEVT v3, using the tracking events EMA (posting/collection) and/or EMC (departure from outward office of exchange) and/or the ITeM ATTribute pre-advice (ITMATT) electronic communication of item information.
