1 Achievements of RTCAP

RTCAP has assisted most of the postal administrations in our region implementing IPS or IPS.POST/IPS Light for mail services and connected to EDI network to exchange EDI messages with their partners. To date, out of 37 DPOs, there are

- 14 postal administrations using International Postal System (IPS)
- 17 postal administrations using IPS Light or IPS.POST System
- 31 postal administrations are connected to POST*Net and exchanging EDI messages with their partners

Please refer to Annex 1 for the summary of the EDI status and the system used by the DPOs in our region up to April 2016.

2 Activities of RTCAP (2015)

In year 2015, RTCAP continued to assist the DPOs in the region to improve their delivery and EDI transmission performance and to assist them to use IPS, IPS Light or IPS.POST system to process for all international mail services.

2.1 Conduct IPS / IPS Light / IPS.POST Training at APPC

2.1.1 IPS / IPS Light Demonstration

RTCAP was invited by APPC to conduct IPS / IPS Light presentation and demonstration in the International Mail Accounting course at Asian Pacific Postal College (APPC) on 24^{th} to 26^{th} February 2015.

There were 11 participants from 8 postal operators attended the course, namely, Afghanistan, India, Indonesia, Lao, Maldives, Nepal, Sri Lanka, and Thailand.

2.1.2 IPS Light Training

RTCAP was invited by APPC to conduct IPS Light training in the IPS / IPS Light workshop at Asian Pacific Postal College (APPC) on 17th to 21st August 2015.

There were 12 participants from 9 countries attended the IPS Light training, namely, Bangladesh, Bhutan, China, Maldives, Myanmar, Nepal, Solomon Islands, Timor Leste and Western Samoa.

2.1.3 IPS.POST Training

RTCAP conducted the IPS.POST training at Asian Pacific Postal College (APPC) for the IPS Light users in the region together with the expert from PTC on 16th to 20th November 2015.

There were 18 participants from 12 countries attended the IPS.POST training, namely, Afghanistan, Bhutan, Bangladesh, Kiribati, Lao, Maldives, Myanmar, Nepal, Samoa, Solomon Islands, Timor Leste and Vanuatu.

- 2.2 Participate in UPU regional Quality of Service and Supply Chain Improvement Project (QSSCIP)
- 2.2.1 RTCAP was invited by UPU to participate in QSSCIP second workshop for Pacific Countries in Auckland, New Zealand on 3rd August to 7th August 2015.

Topics covered were associate EDI messages and events to E2E mail process flow, use QCS as monitoring tool to monitor and improve mail services, different types of EDI message, IPS.POST migration and CDS.

There were 7 participants from 7 postal operators attended the workshop, namely, Cook Island, Fiji, Papua New Guinea, Solomon Island, Tonga, Vanuatu and Western Samoa.

2.2.1 RTCAP was invited by UPU to participate in QSSCIP third workshop for Asian Countries in Manila, Philippines on 30th November to 4th December 2015.

Topics covered were IPS.POST system migration, associate new events in EMSEVT V3 to operation screens in IPS.POST system, use QCS as monitoring tool to improve mail operations and CDS.

There were 24 participants from 13 postal operators attended the workshop, namely, Afghanistan, Bangladesh, Bhutan, Cambodia, Indonesia, Iran, Laos, Myanmar, Nepal, Philippines, Sri Lanka, Timor Leste and Vietnam.

2.3 Participate in APP ePacket workshop

RTCAP was invited by APP to conduct the following topics during the ePacket Workshop at Asian-Pacific Postal College in Thailand on 11th to 13th August 2015.

Topics covered were introduction to mail process flow, scanning and EDI transmission, introduction to QCS with demonstration, introduction to RAIS, RAIS work flow and performing enquiry using RAIS.

There were 40 participants from 16 postal operators attended the workshop, namely, Bhutan, Cambodia, China, Indonesia, India, Korea, Laos, Macao, Maldives, Malaysia, Mongolia, Philippines, Singapore, Sri Lanka, Thailand and Vietnam.

2.4 Participate in EMS workshop

RTCAP was invited to speak on the following topics during the EMS Workshop at Asian-Pacific Postal College in Thailand on 19th November 2015.

Topics covered were introduction to QCS with demonstration, focusing on leg 2 and transport report from QCS.

There were 18 participants from 11 postal operators attended the workshop, namely, Bangladesh, Cambodia, India, Indonesia, Korea, Laos, Macao, Nepal, Samoa, Thailand and Vietnam.

2.5 Conduct Improve Operations (IO) Visit

RTCAP conducted the Improve Operations (IO) Visit for Parcels to China on 26th to 28th May 2015. There were 13 staff attended the IO training workshop.

2.6 Technical and General Enquiry

RTCAP continued to provide support and advice to the technical and general enquiry related to the mails applications and the EDI transmission for the users in the region.

3 RTCAP Planned activities for year 2016

RTCAP will continue to provide assistance to DPOs to improve their delivery performance and EDI transmission performance; and to provide technical assistance with regards to deployment, training and support mission of PTC mails applications as directed or initiated by PTC.

The plan activities for the year 2016 would be focusing on the following 3 areas:

- Provide technical assistance to PTC mails applications
- Conduct IPS / IPS.POST training in APPC courses
- Improve operations visit

3.1 Provide technical assistance to PTC mails applications

To assist DPOs who are using IPS system to migrate to the latest IPS version 2015.

To assist DPOs who are using IPS Light system to migrate to IPS.POST system through training workshop.

3.2 Conduct IPS / IPS.POST training in APPC courses

To conduct IPS / IPS.POST training, presentation and demonstration in APPC courses organised by APPC, namely International Mail Accounting course and International Postal Services course.

3.3 Improve Operations (IO) Visit

As DPOs have expanded to improve their quality of services for mails services other than EMS, RTCAP has started IO Visit for other mails services like parcels service.

As a token of appreciation, RTCAP would like to begin with the DPOs who have contributed to RTCAP SAF.

4. Budget

- 4.1 The Expenditure for RTCAP in 2015 was USD 62,812.75. The amount spent was within the budget of USD 82,000 for 2015.
- 4.2 The budget expense for year 2016 to 2018 is expected to be USD 84,000 annually.
- 4.3 The budget contribution is expected to be USD 65,000 annually.
- 4.4 The amount of the balance of RTCAP Special Activity Fund as at 31 December 2015 was USD 252,038.91.
- 4.5 The excess between the budget expense and budget contribution for 2016 to 2018 will be drawn from the balance of RTCAP Special Activity Fund.
