#### 2. Report of the Reform Working Group – Workplan

- There has been mixed success with meeting the workplan since the 2023 EC meeting.
- There have been some positives a high work rate, good attendance and participation in the online meetings.
- However, the policy position work has been more complex and time consuming than initially anticipated.
- It is expected that the Reform Working Group will still be able to deliver the expected work by the deadline of the 2025 EC.

# 2. Report of the Reform Working Group – Impact of Decisions Taken at the 4<sup>th</sup> UPU Extraordinary Congress



- This work was undertaken by the Reform Consultant and focused on:
  - changes to the UPU General Regulations, and
  - decisions made by Congress other than those amending the Acts (i.e., resolutions, decisions, recommendations, formal opinions, etc).
- For completeness, the review also covered Congress proposals on the:
  - Congress Rules of Procedure;
  - Convention;
  - Final Protocol to the Convention; and
  - Postal Payment Services Agreement.

### 2. Report of the Reform Working Group – 2024 Budget of the Reform Consultant



- A Reform Consultant assists the Reform Working Group.
- In 2024, Reform Consultancy has an approved contract value of US \$19,000.
- The estimates outturn expenditure is as follows:
  - February to May 2024 (invoiced): US \$5,149.69
  - June to December 2024 (estimated): US \$13,850.31
  - Estimated end-of-2024 position: In line with budget

### 2. Report of the Reform Working Group – 2025 Budget of the Reform Consultant



- The Bureau has advised that US \$20,000 has been allocated to cover work to be undertaken by the Reform Consultant in 2025 to support the Reform Working Group.
- This allocation is subject to:
  - (i) approval of EC 2024 Doc 6 and report of the Finance Committee by the Executive Council; and
  - (ii) satisfactory conclusion to 2024 activities as specified in contractual reporting requirements.
- Australia as Reform Working Group will seek to continue the services of the current Reform Consultant.

#### 3. Asia Pacific Post Cooperative update – overview



- The issues with the Asia Pacific Post Cooperative (APP) have been extensively explored by the APPU EC.
- At the 2023 EC, members agreed that the preferred path forward is to amend the General Regulations of the APPU to permit the creation of user-funded subsidiary bodies.
- A number of points were agreed at the 2023 EC to continue work on this topic.

# 3. Asia Pacific Post Cooperative Update – Consultation on holding an Extraordinary Congress

- The Bureau conducted consultation in March 2024 about holding an Extraordinary Congress.
- The results indicated that membership had not consented to holding an Extraordinary Congress.
- Any treaty changes can occur at the 2026 Congress at the earliest.
- This is discussed further in EC 2024 Doc 13.2 (a).

# 3. Asia Pacific Post Cooperative Update – Draft Basic Framework



- The Reform Working Group considered the draft 'Basic Framework' provided by the Chair of the APP Cooperative Management Board.
- The Reform Working Group cannot recommend the draft 'Basic Framework' for adoption by the EC as further work is required.
- The Reform Working Group proposes that discussions continue and an update is provided to the 2025 EC.

#### 3. Asia Pacific Post Cooperative Update – next steps



Further work is required ahead of the 2026 Congress to implement a solution for the APP. As such, it is recommended that the EC asks:

- i. the Chair of the APP CMB to advise the Secretary General and the Chair of the Executive Council on the preferred location of the APP Cooperative no later than 3 months prior to the 2025 Executive Council meeting,
- ii. the APPU/UPU Reform Working Group to continue working with the Chair of the APP CMB to develop the 'Basic Framework', and
- iii. the Secretary General to continue working with the Chair of the APP CMB and the APP Managing Director on operational transition arrangements as required, with the Chair of the APP CMB to report annually to the Executive Council on such activities.

- The first detail report to the EC on the review of governing documentation and archiving project was in EC 2023 Doc 13.3.
- The 2023 EC endorsed a vision to guide the review of governing documentation and has used this to guide the review of governing documentation and development of policy positions.
- There have been several disruptions to this work given unforeseen circumstances and a revised proposed workplan has been drafted.

#### 4. Review of Governing Documentation and Workplan



- Archiving and annotated Acts of the Union overview
- The Reform Working Group and Reform Consultant undertook archiving of Union materials and the development of a fully annotated set of the Acts of the Union.
- This was completed by the 2023 EC and the responsibility for finalising the project was transferred to the Bureau and is now part of the broader Digital Library project of the APPU.
- In the APPU Circular NO. 3 of 2024, the Reform Working Group advised APPU members that the annotated Acts of the Union were available for comment on the document portal.
- Comments were received from one member country which have been incorporated into the wider review of governing documentation.

### 4. Review of Governing Documentation and Workplan –Review of the Acts of the Union and policy positions overview



- The Reform Working Group were tasked in EC doc 13.5 with developing policy positions and proposing solutions for endorsement by the membership at the 2024 EC.
- The themes drafted for consideration include:
  - Purpose and functions of the Union
  - Creation and maintenance of the Union
  - Cooperation
  - Structure of the Union
  - Organs
  - Treaty Meetings (Congress)
  - Less than Treaty Meetings (Executive Council)
  - Administration

### 4. Review of Governing Documentation and Workplan – Review of the Acts of the Union and policy positions overview



- The Reform Working Group have taken a thematic approach with the policy position papers.
- The Reform Working Group created an ad-hoc team to progress the Wider Postal Sector Players policy position.
- Resourcing constraints and a greater complexity of work than previously identified have collectively meant that the Reform Working Group has not been able to finalise all policy positions for endorsement by membership at the 2024 EC.

# 4. Review of Governing Documentation and Workplan – Policy positions



- Nine policy positions have been finalised for presentation at the 2024 EC.
  - Objectives and functions of the Union
  - Centre of excellence
  - Regional representation
  - Membership
  - Reservations
  - Accession
  - Ratification
  - Withdrawal
  - User-funded subsidiary bodies

# 4. Review of Governing Documentation and Workplan – Objectives and functions of the Union policy position



- First policy position discussed by the Reform Working Group.
- Encompasses the agreed vision for the APPU, as addressed in EC 2023 13.1.
- Details on the objectives and functions of the APPU in the treaty documents is limited and does not describe the actual services and functions that the APPU and the Bureau provides.
- **Recommendation:** expand the objectives and functions statement to encompass the key functions identified in the vision.

# 4. Review of Governing Documentation and Workplan – Centre of excellence policy position



- APPU treaty documents do not currently discuss aiming to be a 'centre of excellence' but is included in the APPU's vision statement and APPC.
- Reform Working Group discussed that it was important to identify the APPU's aspirations and provide direction.
- Closely linked with the Objectives and functions of the Union paper.
- Recommendation: Incorporate the APPU's intention to be a 'centre of excellence' in an expanded objectives and functions statement in its treaty documents.

# 4. Review of Governing Documentation and Workplan – Regional representation policy position



- APPU treaty documents reference representation of the Union, however the provision includes a limited mandated responsibility for the Secretary General.
- Reform Working Group discussed the importance of the APPU having the ability to represent both the region and the postal sector, including as an observer at the UPU.
- **Recommendation:** Include an explicit representation function in the APPU to ensure that the current level of representation is maintained and continues under future administrations, if desired by members.

# 4. Review of Governing Documentation and Workplan – Membership policy position



- Current requirements for membership of the APPU are split between two Articles in the Constitution:
  - Article 2 'Members of the Union', and
  - Article 6 'Accession to the Union'.
- Issues with current provisions and potential scenarios that are not currently covered in the APPU's treaty documents, including if a member of the APPU leaves the UPU.
- Reform Working Group discussed that the intention of updating the wording is to ensure that the current membership and eligible countries within the geographical boundaries are not changed.
- Recommendation: List the membership requirements in Article 2, rather than Article 6, and ensure that membership requirements are met on an ongoing basis (not only on joining).

# 4. Review of Governing Documentation and Workplan – Reservations policy position



- APPU has two Articles in its Constitution which include provisions for members to make reservations on joining the APPU:
  - Article 6 'Accession to the Union', and
  - Article 14 'Acts of the Union'.
- Also Article 113 'Reservations' in the General Regulations, which include a provision to make reservations at Congress.
- There are several gaps with the provisions for reservations, including an unnecessary provision for reservations upon accession which is no longer required.
- Reform Working Group discussed that while member countries do not currently have any
  reservations in practice, there could be value in allowing for reservations at Congress to
  occur in the future against Chapter V of the General Regulations.
- **Recommendation:** Remove the ability for reservations upon accession the UPU and make the parameters of reservations (during membership) clear in the Constitution.

## 4. Review of Governing Documentation and Workplan – Accession policy position



- Issues with the accession protocols are detailed in Congress 2022 Doc 24.9 Appendix 4 include a redundant provision that was copied from the UPU's governing documentation that is not applicable to the APPU's context.
- Consultation with existing members on accession of prospective members does not currently happen and this would not represent procedural fairness.
- Policy position closely linked with the membership and reservations policy positions.
- Recommendation: move the geographic boundaries from the accession Article into the membership Article (the criteria for joining the APPU will remain materially unchanged).

# 4. Review of Governing Documentation and Workplan – Ratification policy position



- Reform Working Group discussed the importance of members continuing to be able to give proxies the authority to represent, speak and vote on behalf of another member (particularly in unforeseen circumstances such as COVID-19).
- However, there is no material reason for allowing proxies for signing the Acts of the Union, something which could cause confusion.
- **Recommendation:** Align the APPU Article 15 with the UPU Article 24 to specify acceptance and approval as valid forms of ratification and remove the ability for proxies to sign the Acts of the Union on behalf of the member they are representing.

### 4. Review of Governing Documentation and Workplan – Withdrawal policy position



- APPU treaty documents do not include a clause that requires member countries to meet their operational obligations during the period between the notification of withdrawal to the effective date of withdrawal, which is one year from notification.
- Recommendation: Expand the existing withdrawal process to clarify that members must meet all current and outstanding financial and operational contributions.

# 4. Review of Governing Documentation and Workplan – User-funded subsidiary bodies policy position



- APPU treaty documents do not currently have any provisions about userfunded subsidiary bodies or the ability to create these within its current treaty framework.
- This has been previously discussed within the context of the Asia Pacific Post Cooperative.
- Reform Working Group discussed ensuring the Union had flexibility to respond to future needs and considering specific operation requirements of user-funded subsidiary bodies as needed.
- Recommendation: create a new provision in its General Regulations which would allow the EC to establish and administer user-funded subsidiary bodies.
